

## Lawton Municipal Court Fine and Cost Schedule:

**NOTE:** On-line and telephone payments require all fines to be paid in full.  
No partial payments will be accepted

**FOR ALL TRAFFIC VIOLATIONS INVOLVING AN ACCIDENT THE FINE IS INCREASED BY \$50.00**

**\*Security verification (proof of liability insurance):** This \$275 ticket can be paid through nCourt(on-line or by telephone). However, if a defendant produces and brings to the City of Lawton Municipal Court satisfactory evidence that there was sufficient liability insurance at the time of the citation, the charge will be dismissed without cost provided such proof of coverage is produced on or before originally scheduled court date and verified by the court. If valid coverage at the time of the citation is presented after the original court date, the citation will be dismissed for \$56.00 in court costs/fees.

**\*\*Defective motor vehicle equipment:** This \$175 ticket can be paid through nCourt, (on-line or by telephone). However, if the defendant produces a receipt/proof on or before originally scheduled court date, showing that the defect was corrected, the charge will be dismissed without cost. If proof is provided after original court date, the citation will be dismissed for \$56.00 in court costs/fees.

**\*\*\*Vehicle Registration Violation:** This \$175 ticket can be paid through nCourt, (on-line or by telephone). However, if the vehicle registration (tag) is corrected on or before the originally scheduled court date, the citation will be dismissed for \$76.00 in court costs/fees.

**On-line and/or telephone PAYMENTS MAY NOT BE MADE ON ANY OF THE FOLLOWING types of citations:**

- Any driver's license related offense
- Any drug or alcohol related offenses
- Any citations issued by animal welfare, (such as running at large, no city license, no vaccinations, etc.)
- Any citations issued by Neighborhood Services (such as citations for junk & debris, improper storage of a motor vehicle, tall grass/weeds, etc.)
- Any citations issued by Revenue Services (such as citations for water restriction violations, tampering with utilities, etc.)
- Any/all citations that have not been paid within 15 calendar days passed the listed court date, (NOTICE: a new charge and an arrest warrant will be issued after this 15 day grace period).

**Additional information on Driver's License related citations:**

Note:

Offenses related to Drivers Licenses **MAY NOT** be paid on-line or by telephone.

- If you had a valid driver's license, but didn't have it with you at the time you received a no valid driver's license citation, it will be dismissed without cost, "IF" you show proof prior to your court date.
- If you had a valid license, but bring in proof after your court date, it will be dismissed for \$76 in court costs/fees.
- If you did not have a valid driver's license at the time of the citation, but obtain a valid license prior to your court date, the citation will be dismissed for \$126 in court costs/fees.
- The fine for not having a valid driver's license, if it is your first such offense, is \$176. Subsequent offenses are higher and determined by the Judge.
- The fine for driving with a suspended or revoked driver's license, if it is your first offense, is \$276. Subsequent offenses are higher and determined by the Judge.
